Indicate division and, if applicable, committee to which material is being submitted. The use of SI units is preferred; if other units are used, SI equivalents must also be given. Write or phone the Journals Department for *ASCE Authors' Guide to Journals, Books, and Reference Publications* for complete instructions for manuscript preparation.

Reprints for authors are ordered prior to publication; others may order them by using the coupon published in *ASCE News* and *ASCE Publications Information* or contacting the Reprint Department, ASCE.
